#### Agenda Item 74 Dark Skies Campaign

The Dedhan Vale Society wrote in March regarding their proposed Dark Skies Campaign as follows:

"You may already be aware that the Dedham Vale Society is campaigning for Dark Sky Status for the Vale and the AONB within it. We are anxious to preserve the existing low light-pollution in the area and have been extensively measuring and recording the light-levels throughout the valley. Despite being only an hour or so from London, it is mostly very dark and by fulfilling the requirements of the Dark Skies Association, (IDA), and obtaining the relevant certification we hope to keep it that way. It would give some say over main highway illumination as well as local street lights and commercial lighting and additionally give some clout with householders too, helping to explain and educate in the use of security and general outside lighting, more careful aiming, and the use of shields, timers and motion sensors.

We are writing to local MPs and County Councillors to notify them of our campaign as well as to other amenity organisations in addition to bodies such as the National Trust and those responsible for National Parks.

The reason for us writing to you is to ask if we have your backing for this initiative. In due course we may need a letter of support from you to include in our application. There are a number of these Dark Sky reserves in the UK, most of which are in the North of England and Scotland, very few in the South and none as close to the capital as the Dedham Vale."
