Agenda Item 122 Trees, hedges and wildflowers

Richard Kilshaw wrote to PPC with the following proposal.

Some while back you asked if I had any ideas regarding the wildflower and tree offer from Babergh.

I've since spoken with Ruth Riddleston to suggest wildflower enhancement of the rectangular grassland area between the playing field and fp8 from Heath Road into Dollops wood. The field fence-line on the north side of fp8 could also be enhanced with a native species hedgerow trees across the filed.

Ruth was very keen on the idea although emphasised they wouldn't be taking on any extra work involved, but would continue to cut it once a year in order to comply with some agricultural scheme or other.

This grassland area is former arable - approx 20 years ago - but poor soil and has accumulated quite a range of native species already, so would be good candidate for some plug planting or seeding enhancements, plus a few management tweaks to create a wildflower 'meadow', rather than having to start from scratch. Similarly the fence-line has numerous self-established trees and shrubs making it ideal for infilling with hedgerow planting, possibly leaving some of the established trees to go on to form standards.

As both the fence-line and grassland are alongside a public footpath these enhancements would benefit both the local community and wider public.
