The owners of Polstead Pond have been successful with another grant application this time from the fisheries improvement programme. Ownership of the main roadside bank has been a matter of debate for over 50 years. Suffolk County Council are understood to have installed the railings before WW2 but have not accepted ownership of the bank. According to records held by the late Henry Engleheart, without prejudice to the question of ownership, Suffolk County Council have repaired and decorated the railways on a number of occasions in the last 50 years. Cllr Engleheart to write to CCllr Hall to request funding from the locality budget.
