# 10/101 Apologies for Absence

#### 10/102 Declaration of Interests

None were declared.

# 10/103 Minutes of Meeting held on 20th May 2010

The minutes of the meeting were approved and signed by the Chairman as a correct record.

#### 10/104 Reports from County and District Councillors and Suffolk Constabulary

The reports are contained in Appendix A.

#### 10/105 Reports and Question from Councillors

- a. Cllr Kilshaw reported that the ramp had been fixed in the playing field and that the new gate will be installed on 21<sup>st</sup> June. Maintenance work was in hand for FP 8, FP 12, Byway 13 and Byway 34 with the contractor. The Polstead Playground Group has now received the refund of the insurance premiums and will now arrange for their funds to be transferred to PPC. The funds will be ring fenced for the ongoing maintenance of the equipment now that it had been adopted by the PPC. Cllr Kilshaw also raised questions of the Village Hall project regarding birds nesting in the hedge alongside the Community Shop and the presence of protected reptile species in the bank. The councillors resolved that as the Village Hall project was outside the remit of PPC that Cllr Kilshaw should address any further issues with the Village Hall Committee as an individual outside of the council meeting. Cllr Kilshaw left the meeting as he had indicated at the commencement of the meeting.
- b. Cllr Hackford reported that substantial progress had been made regarding the Village Hall area at the meeting of the various groups on the 15<sup>th</sup> June. He also raised concern that the proliferation of painted stones being placed on verges by homeowners will be an issue in the event of an accident should the land be owned by Suffolk County Council Highways.
- c. Cllr Ravensdale reported that the new dog bin at the entrance to the allotments was now being emptied by Babergh District Council. She also requested that the missing sign at the playground be replaced as quickly as possible. The councillors resolved that the Clerk was authorised to purchase the appropriate sign. *Local Govt (Misc Provisions) Act 1976 s 19*
- d. Cllr MacWilson requested the Clerk to seek the status of the telephone boxes at Polstead Heath and Stackwood Road with BDC / BT as both were now falling into a state of disrepair.

#### 10/108 Finance

#### 10/109 Highways and Footpaths

- a. No further feedback has been received by David Yorke-Edwards on the progress of the proposed scheme at the junction of Stackwood Road / A1071.
- b. SCC's response that "If a haulier is repeatedly driving down an unsuitable minor road or is causing another lorry related issue, please complete the HGV Incident Report Form and we will contact the relevant Haulage Company and take action if necessary" was noted by the councillors. The Clerk will send copy of the Report Form to councillors for circulation to any concerned resident.
- c. The councillors reviewed the revised proposals for the diversion of sections of Footpath 8 and 32 at Sprotts Farm and resolved that they had no objections.

#### **10/110 Hog Roast**

The councillors reviewed the option for the provision of "play workers", recommended by BDC, and resolved to hire 2 coaches from 2.30pm to 5pm to arrange activities for the 5 to 14 year old group at a cost of £85. **LGA 1972 s 145** 

The Clerk updated the councillors that Allianz does not insure tug of war events under its standard public liability cover. The Clerk circulated the Special Events Guidelines factsheet received from Allianz which outlines recommendations that PPC should comply with in respect to public liability cover at the Hog Roast event.

The Chairman and Clerk are to prepare the Temporary Event Notice required by BDC for agreement at the next meeting.

There will be a informal meeting of councillors to discuss the plans for the Hog Roast on Thursday 29<sup>th</sup> July 2010 at 7.30pm.

#### 10/111 White Street Green car parking

The Clerk read correspondence received from Maureen Cooling on the issues of car parking at White Street Green. Cllr Flather reported that she had sought the views of residents around White Street Green and that the consensus was that no additional measures were required at this time. The councillors resolved that no action was required.

# Appendix A County, District and Suffolk Constabulary reports and Public Forum

David Yorke-Edwards updated the meeting that SCC and Suffolk Constabulary are now reviewing their property portfolio but was pleased to report that neither Hadleigh not Caple St Mary police stations were on the review list. He also updated councillors on a consultation about to be conducted on Police Station opening times.

Sue Wigglesworth gave councillors the background the Decision Making Survey currently being conducted by BDC.

In the absence of PC Garrod the Clerk read out the following report "I have checked back to the date of your last meeting on 20th May and there have been no crimes reported in the Polstead area since then. This is very good to see considering there were 153 crimes reported in the Hadleigh District during this time. Between the meeting on the 20<sup>th</sup> May and your previous meeting to that on 15<sup>th</sup> April there were only two crimes reported both being minor criminal damage. One was to a field fence and the other to a caravan over an unknown period of time. Both of these crimes are undetected with no further leads to follow up on".
