Appendix A County, District and Suffolk Constabulary reports and Public Forum Sue Wigglesworth (Babergh District Councillor) updated councillors on the 3.5% increase in council tax set by BDC which would mean that free short term parking would continue in Sudbury and Hadleigh; the £1.3m that will be saved by merging the officer functions with MSDC; the £84 million debt that BDC has inherited from the Government with regard to the housing deficit which would be financed by BDC retaining all council rent income. David Yorke-Edwards updated councillors with news that there was a 0% increase in council tax at SCC.
