### **13/115 Declaration of Interests**

Cllr Martin had written to declare his pecuniary interest in Item 13/124b as he is a neighbour of the applicant.

### **13/116 Requests for Dispensation**

No dispensation requests received.

### **13/117 Minutes of Meeting held on 16<sup>th</sup> May 2013**

The minutes of the meeting were approved by the councillors and signed by the Chairman as a correct record.

### **13/119 Reports and Question from Councillors**

Cllrs MacWillson and Palmer to propose locations for dog bins at the July meeting.

### **13/120 Chairman's Report**

The Chairman updated councillors on the:

- Progress of discussions with SCC Right of Ways over the issue of responsibility of a drain on FP30 near Mr Rushton's house. Councillors resolved that a letter be sent to RoW raising PPC's concerns on resolving this issue before wet weather causes further problems.
- The work undertaken by Mr Seager on the removal of brambles and sycamores in the play area. A letter of thanks to be sent to Mr Seager for his work.
- The possible re-routing of FP51.
- Footpath maintenance is running well but any issues with footpaths should be reported to Cllr Baxter.
- A request for a contribution towards a new no parking sign at the Village Shop will be considered at the July meeting.

The applicant updated councillors on the reasons for the Christobel planning application. A neighbour of the Scotland Place Farm raised her concerns on the application for change of use.

- b. The councillors reviewed Planning Application B/13/00377 Scotland Place Farm, Scotland Street - Change of use of agricultural land for educational visits and leisure activities and erection of shelter (retention of) and resolved that they objected to the application. The councillors believe that the existing use of the land for non-agricultural activities for a maximum of 28 days a year is sufficient bearing in mind the location of the site and road access.

### 13/126 Highways and Footpaths

The Clerk was asked to liaise with SCC's suppliers to obtain a quotation for the 2 new kissing gates on FP30.

### 13/127 National Grid

The councillors reviewed National Grid's consultation on the Baseline Data Request to Support the Socio-Economic and Land Use Assessment as well as the issue raised by Chattisham and Hintlesham Parish Council to have professional planning advice being provided by NG to Parish Councils in order to review the consultation data. The councillors resolved to respond to NG that there is no reference in the consultation document to a study of the use of footpaths in Polstead, as was previously promised by NG to be undertaken, nor reference to the Ramblers Association being consulted. PPC understand that over 500 walkers used the footpaths through or past Dollops Wood over a bank holiday weekend in May 2013. The councillors further resolved to support the request by Chattisham and Hintlesham PC in PPC's response. The Clerk to provide Gordon Jones with copies of PPC's responses to NG to date.

### **13/128 Emergency Plan**

Cllr Palmer updated councillors on the 30 responses received from residents in relation to the preparation of an emergency plan for the hamlets in Polstead. The councillors agreed to hold a meeting with residents interested in the project at the Village Hall on Thursday 19<sup>th</sup> September 2013 starting at 6.30pm. The PPC meeting will follow the meeting at 7.45pm.

### **13/129 Neighbourhood Plan**

The councillors reviewed the progress of plans for the public meeting on the 3<sup>rd</sup> July to look at the issues that Polstead residents face in the next 15 years. The Clerk was asked to provide councillors with a copy of the presentation, that the independent consultant will be using on the evening, ahead of the meeting. Cllr Baxter will circulate ahead of the meeting, a summary of the responses received from residents.

### **13/130 Village Show**

The 17<sup>th</sup> August has been set for the Village Show and the councillors reviewed the plans for the event. The event committee is now resident driven with Cllr Baxter acting as Chairman. The councillors are supportive of funding elements of the Village Show and will consider these requests at the July meeting. Cllr MacWillson requested that the name "Village Show" should be changed as not to confuse residents with the content of the previously run "Produce Village Show". The Clerk was asked to confirm the bookings for a Punch & Judy show and the Village Hall for the 17<sup>th</sup> August.

### **13/131 BDC Consultations**

The councillors resolved that Cllrs Baxter and Palmer draft the responses to the Core Strategy and Affordable Housing consultations with the Clerk circulating the draft to councillors before submission to BDC.

- a. The councillors reviewed the proposed revisions to the Core Strategy and agreed that they had no comments.
- b. The councillors reviewed the proposed draft (New) Affordable Housing Supplementary Planning Document (SPD) and agreed that they had no comments.

### **13/132 Councillor Training**

The councillors resolved that the Clerk arranges a training session for the Autumn to cover "Roles and Responsibilities" with a budget of £300. **LGA 1972 s 111**

Gordon Jones updated councillors on SCC’s review of National Grid’s proposed power line, and the road works planned for the village. In the absence of the Police the Clerk read their report “There have been three reported crimes since your last meeting on 16th May.
