11/155 Minutes of Meeting held on 15th September 2011

11/157 Reports and Question from Councillors

11/161 Highways and Footpaths

- a. The Clerk was asked to raise the issues of pot holes in Mill Street and the footpath to the Church with SCC. There were a number of issues re footpaths raised as follows:
 - i. Cllr Brandt to obtain a quote for the cost of tree removal at Flaggy Pond
 - ii. Cllr Brandt to assess stile at Frogs Hall
 - iii. Cllr Brandt to obtain a quote for the cost of replacing stiles and gates on FP30 with a kissing gate
 - iv. FP8 to be maintained
- b. The councillors resolved to adopt the bench at Heath Close and include in the Asset Register. Cllr Baxter will treat bench ahead of winter.

11/162 Diamond Jubilee

Cllr Brandt reported that the plans for the Diamond Jubilee event on the 3rd June were now in place. He has updated the other groups in the village on the progress and will now arrange a further meeting with the groups in the New Year. The councillors resolved that tickets for the event on the 3rd June would be priced to Polstead residents at £1 for an adult and £1.50 for a family with all proceeds from ticket sales being donated to the Friends of Polstead Church.

11/163 Christmas Carols

The councillors resolved that the Christmas Carols will be held on Friday 23rd December starting at 6pm in the Village Hall. Cllr Brandt will talk to Sue Wigglesworth regarding the Christmas Tree. Clerk to reserve hall and produce posters for the event. Cllr Brandt will supply wine and Cllrs Flather and MacWillson will arrange food etc for the residents. *LGA 1972 s 145*

11/164 Local Housing Needs Survey

All the paperwork for the Local Housing Needs survey has now been received from Suffolk ACRE and the Clerk. Cllr Baxter will arrange for collation of the literature for delivery to each household in Polstead as well as small supply for Cllr Brandt for enquiries.

11/165 National Grid

Cllr Palmer updated councillors on National Grid's Community Forum which he attends on PPC's behalf. The meetings will be run monthly for the next 12 to 18 months. Following this the planning application is expected to take 12 months with construction of the power line in 2014 / 2015. There are 4 Community Forum groups covering the route geographically and 3 special interest groups representing biodiversity, landscape and heritage. The priorities set for the forum are:

- Merits of undergrounding
- Preferred corridor around Hintlesham
- Substation site location near Twinstead.

Cllr Palmer was asked to represent all the views of the councillors when attending the event.

11/166 SCC's Budget Challenge consultation

After reviewing the consultation document from Suffolk County Council the councillors resolved that PPC did not have sufficient information or background knowledge to comment on the issues raised. However, they felt that SCC councillors should manage the budget in whatever way they thought best.
